BAY AREA LATINO LAWYERS FUND


BALLF is a charitable organization that supports the legal profession through educational programs, community building, business and professional development, and pipeline programs.

OUR WORK

Below are samples of our work. We continue to grow our programs and services every year. We can only grow with your support.



Educational Programs

Our educational programs focus on legal education and professional development. We started the **Bay Area Latina Leadership Academy**, a half-day program geared towards Latina legal professionals. Previous topics include overcoming professional barriers, networking, and business development.

Other general educational programs include Navigating Microaggressions & Healing for Latinas in Law, Succeeding as a New Partner, Growing Your Business, and Making the Most Out of Mediation.

Relationship Building

Relationship building is vital to the success of our community. We design events for people to establish genuine relationships and business opportunities. Our events have included in-house counsel dinners, Latina lunches, new partners' receptions, and judge appreciation nights.

Pipeline Programs

Pipeline programs are essential to growing the next generation of attorneys and judges. Programs include our annual speed networking event, an on-demand mentorship program, and general mentorship connections that have formed organically at our community events. Our speed networking event takes place every January, with as many as 120 participants.

Scholarships

Our scholarships support students from all backgrounds. There are scholarships for students taking unpaid internships with non-profit organizations, first-generation law students taking the California bar, LGBTQ+ students, and students who are ineligible to receive government financial aid.



We provide nearly \$25,000 in scholarships a year. All of our scholars have been first-generation law students, and most were the first in their family to attend college. Our scholars come from all of the ABA-approved law schools in Northern California. All our bar scholars have gone on to pass the bar. Our public interest scholars have worked on issues that include, but aren't limited to, wage theft, climate control, consumer fraud, eviction defense, and helping undocumented families.



Noche de Gala

Noche de Gala is our annual dinner, which brings inhouse counsel, partners, non-profit attorneys, judges, and legal professionals together. The dinner is on **November 1, 2024** at the Palace Hotel in San Francisco. We honor the best in the profession while creating a space for community building and business development.
